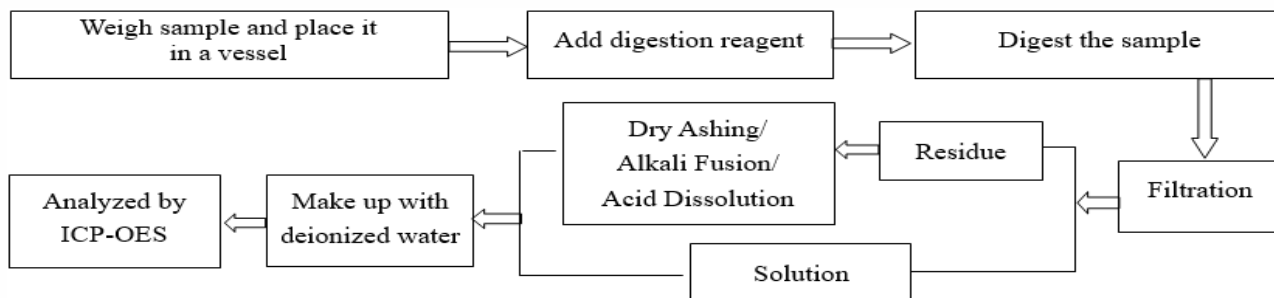

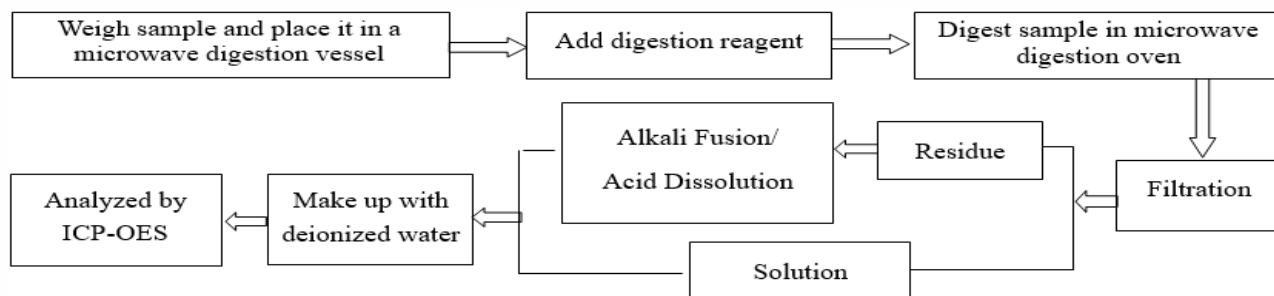

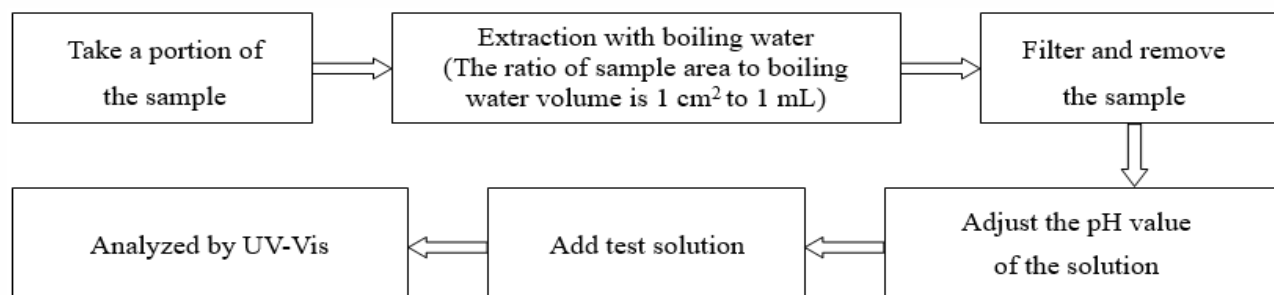


2. Mercury (Hg)

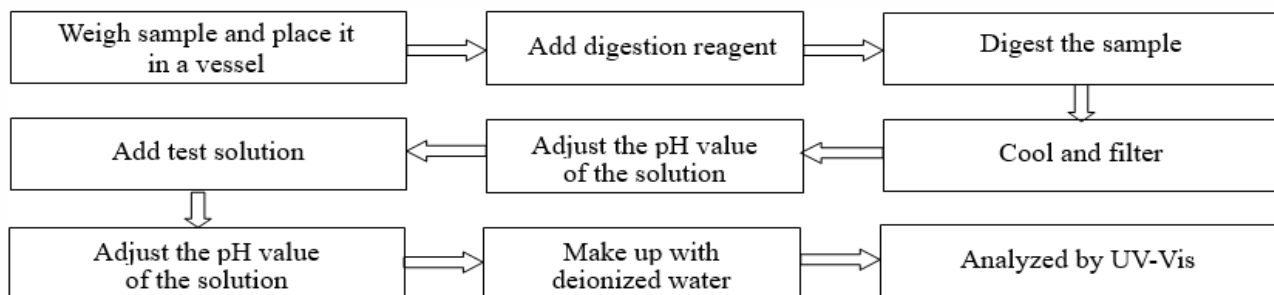


3. Hexavalent Chromium (Cr(VI))

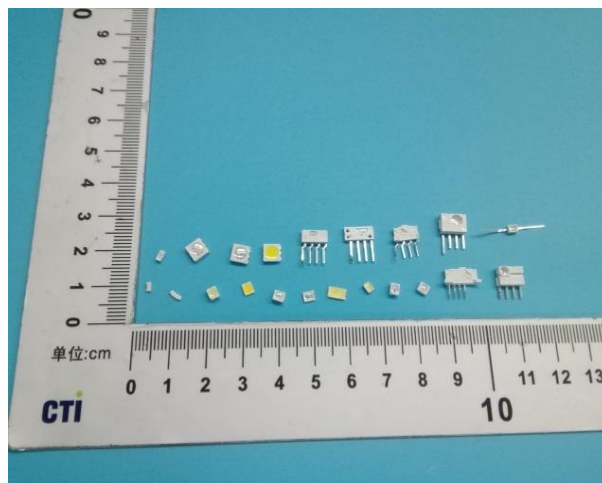
